Then around early December, The Tasting Room, tapped once again as the event venue, will house the Second International Chef Series featuring Chef Curtis Duffy of Chicago's Grace Restaurant, a two-time winner of three Michelin stars, who will be making his Macau debut. More details will be announced in the coming months.
